# **FLE Learning**

FLE has also organised and provided various intensive onsite training programmes to public sector organisations and firms in the past years to develop and improve their controls and systems so as to ensure effective compliance with financial crime laws and regulations. Registered experts from the company also provided technical assistance to different firms to develop their risk portfolio by assessing various risks facing the firm and to update and improve the firm's internal controls and systems to efficiently detect and prevent potential financial crimes.

FLE (previously known as 'FLE Legal Education') was established in 2005 as the foremost provider of the Qualified Lawyers Transfer Test (QLTT) in the Indian Sub-Continent, and was set up with the support of the Law Society of England and Wales and the British High Commissioner, New Delhi. QLTT was conducted in India by FLE in conjunction with Central Law Training (CLT), UK, and successful completion allows practising Indian lawyers to be admitted to the Roll of Solicitors of the Supreme Court of England and Wales. The programme was launched in India to allow Indian lawyers to take this test while in their home country.

She graduated with a PhD degree in Corporate Governance and Law from the University of Portsmouth in 2015 and immediately pick up a lectureship position with the University of Hertfordshire. Ernestine as a Phd student attended the first Annual International Conference on Law, Economics and Politics in Oxford and presented a paper titled 'The Role of Law in the Determination of Director's Remuneration'. Ernestine co-convene and chaired a session at Southern Law PhD Conference 2015 in Portsmouth. Ernestine's research interest lies in Company Law and Corporate Governance and Employment Law particularly on the impact of excessive director's remuneration on the employee, the shareholder and the company. Within two years of starting her career, Ernestine has been successful in two early career research grant to work on projects such as zero hours contract and shared parental leave. ### Information about the - Newnham College - Conference Venue

Newnham is one of the 31 colleges of the University of Cambridge. College have 370 undergraduates, 285 graduate/postgraduate students, and about 70 academic staff. The College is set in beautiful gardens with an adjoining sports field and tennis courts, just across the road from the University's Sidgwick site and about 10 minutes' walk from the historic centre of Cambridge.

The College was established in 1871 as one of the first women's colleges. Newnham is still a women's college, and the only undergraduate college with an all-female Fellowship.

Please note that Silver Street is closed to cars for part of the day, and has a 'tidal flow' system for the rest. At most times it will be easier, when approaching the College from the southern part of Cambridge, to use Fen Causeway.

#### By Coach

#### By Road

From the South & from London, Cambridge is a short trip up the M11 motorway. From the north, the A1 and M1 link to the A14 dual carriageway straight to the city, and from the east and west, the A14 again takes you to Cambridge.

For short stay trips the City Centre Car Parks offer great convenience, but for longer visits there are five world class Park & Ride sites located on the outskirts of the City that provide free parking and a swift and frequent bus ride to the City Centre.

#### **By Train**

There is a fast and frequent rail service from London King's Cross & London Liverpool Street through to Cambridge. There are excellent connections from Scotland & the North via Peterborough, and regional services from Birmingham & the Midlands, East Anglia & the Northwest. For bus services from Cambridge railway station into the city centre look for the Citi 1, Citi 3 or Citi 7 services.
